A. Context, Purpose and Scope of the evaluation
<b>Context</b>
<p>Environment Action Programmes have guided the development of EU Environment policy since the 1970s, and each programme has been duly assessed to see if the objectives have been met. The <a href="#">7<sup>th</sup> Environment Action Programme</a> (7<sup>th</sup> EAP)<sup>1</sup> is an agreed framework for EU environmental policy-making to guide action up to and beyond 2020. Its general objective is to improve the state of the EU's environment and citizens' wellbeing, whilst contributing to the EU's broader objectives of smart, sustainable and inclusive growth.</p> <p>The 7<sup>th</sup> EAP set out nine priority objectives and what needed to be done to achieve them including new and on-going or planned EU environmental and climate actions. The framework was to ensure progress in terms of delivery by enabling smarter, faster and better co-ordinated action by:</p> <ul style="list-style-type: none"> <li>• setting out a multi-layered approach: the 7<sup>th</sup> EAP has a vision to 2050, nine priority objectives to be met by 2020 with 36 sub-objectives and 60 actions to be undertaken.</li> <li>• the nine priority objectives reflect the main goals: three main thematic objectives (preserving our natural capital, turning our economy into a resource-efficient one, and protecting citizens from environment-related pressures); complemented by four enabling framework objectives related to implementation, information, investments and integration; and two horizontal objectives to ensure action at international and city level.</li> <li>• establishing joint responsibility to deliver on the objectives: both Member States and the relevant Union institutions committed to the 7<sup>th</sup> EAP and agreed joint responsibility for its delivery.</li> </ul> <p>The 7<sup>th</sup> EAP was a response to a number of serious environmental challenges that were becoming increasingly broad-ranging and interlinked across the areas of: climate change; nature and biodiversity; natural resources and waste; and environment, health and quality of life. Because they are increasingly</p>

complex and linked, the 7<sup>th</sup> EAP put emphasis on the enabling framework to ensure more coherent responses.

### **Purpose and Scope**

The **purpose of this evaluation** is to assess the 7<sup>th</sup> EAP and submit a report based on this evaluation to the European Parliament and to the Council.

The **focus of the evaluation will be on the structure and strategic role played by the 7<sup>th</sup> EAP**: that is its multi-layered approach, dual focus and the joint responsibility to deliver. Essentially it will ask if this agreed framework is really helping us to deliver the nine priority objectives in a smart way. Evaluating the structure will require a basic assessment of the link between the structure and the actions undertaken under the 7<sup>th</sup> EAP and the progress towards achieving the 7<sup>th</sup> EAP's different sub-objectives. In doing so, the evaluation will consider the impact of relevant actions taken at Union and Member State level given their shared responsibility for the 7<sup>th</sup> EAP.

Given this focus, it will be necessary to gather and analyse at a high level evidence related to the different policy areas and priority objectives to allow for an overview of the state of play and of implementation. However, this evaluation will not provide an in depth evaluation of EU environmental policy in any particular area. This means that the evaluation will not prejudge the results of any other evaluation work<sup>2</sup>.

The evaluation will address the following **evaluation questions** against a baseline of continuing EU and national environmental policies, but with no over-arching environmental action programme. It will cover the EU28 and focus on progress since the adoption of the 7<sup>th</sup> EAP.

#### **Effectiveness:**

- To what extent has the 7<sup>th</sup> EAP enabled more predictable, faster and better co-ordinated actions by the EU and the Member States?
- To what extent has the 7<sup>th</sup> EAP been useful in engaging different stakeholders?
- How has the 7<sup>th</sup> EAP structure contributed towards achieving its nine priority objectives?

#### **Efficiency:**

- To what extent has the 7<sup>th</sup> EAP created synergies or opportunities for streamlining, and cost saving at various levels?
- To what extent has the 7<sup>th</sup> EAP been useful in identifying and addressing information needs and thus supporting efficient and effective policies?

#### **Relevance:**

- To what extent does the 7<sup>th</sup> EAP address the challenges of EU environmental policy in a proportionate way?
- How flexible is the 7<sup>th</sup> EAP approach to allow new and emerging issues to be taken into account?

#### **Coherence:**

- How consistent with each other are the nine priority objectives and their actions?
- To what extent is the 7<sup>th</sup> EAP integrated and coherent with other EU policies and strategies, including the Juncker priorities and the Europe 2020 Strategy?

- To what extent is the 7<sup>th</sup> EAP coherent with international commitments, including the 2030 Agenda and SDGs?

**Added value:**

- What is the additional value resulting from the 7<sup>th</sup> EAP compared to what could be achieved by EU environmental policy without such a framework?

## B. Better Regulation

### Consultation strategy

Whilst the approach is not yet finalised, it is expected that as a minimum, the stakeholder consultation to support this evaluation will consist of:

- A 12 week public consultation will take place in the first quarter of 2018. The public consultation will be carried out in all languages. The public consultation will be accessible via the Commission's [central public consultation page](#).
- A targeted consultation involving specific interest groups to allow different aspects to be explored in more depth. A balance of representation among the different stakeholders will be ensured (including NGOs, business, academia).
- EU Member States will also be consulted separately, for example, this could be through a questionnaire targeting National Ministries for Environment and Climate Change. Relevant regional and local authorities and Members of the network of Environmental Protection Agencies in Europe, will also be consulted where possible;

A synopsis report in English, summarising the results of all consultation activities will be published on the public consultation page once all consultation activities are closed.
